#### **CONCEPT NOTE**

#### **BACKGROUND**

2024 will be a key year for the Paris Agreement, as another piece of the system will enter into full force: the **Enhanced Transparency Framework** (ETF). The ETF is a central component to the design, credibility, and operation of the Paris Agreement. According to the modalities, procedures and guidelines (MPGs) of the ETF, Parties to the Paris Agreement shall submit their first Biennial Transparency Reports (BTR) by 31 December 2024. Many countries have already started preparing their first BTR, however they are facing a variety of challenges, potentially hindering a timely submission. Yet, a timely submission of BTRs is key for the successful and long-term implementation of the Paris Agreement. It is needed to set up the regular cycle of reporting and review which is essential for creating trust and accountability among Parties. The reports will additionally serve as a key input for the NDC Updating Cycle in 2025 as well as the second Global Stocktake that will take place in 2026-2028.

#### **OBJECTIVE**

Against this background, the Partnership on Transparency in the Paris Agreement (PATPA) will host a Global Dialogue on BTR preparation. The aim of this event is to provide developed and developing country Parties with a space to discuss the progress in developing their first BTR and exchange on common technical challenges. It will serve to create momentum and support Parties in the last mile of their BTR preparation.

#### **OUTCOME**

The proposed outcome of the dialogue is for participating countries to have defined priority actions on how to overcome challenges for a timely BTR submission. Additionally, the Dialogue will deliver a summary of lessons learned for a general technical public.

#### TARGET GROUP

BTR coordinators from around 35 developed and developing countries.

#### **FORMAT**

The exchange combines inputs by experts and interactive elements during **4 working days**, within a **safe and confidential space**. The working language of the Dialogue will be **English**.



### **EMILIE BEAUCHAMP** INTERNATIONAL INSTITUTE FOR SUSTAINABLE DEVELOPMENT (IISD)



Emilie is the lead on monitoring, evaluation, and learning (MEL) with IISD's Resilience program for the past two years. She works closely with the NAP Global Network and other IISD on designing and implementing MEL systems for climate change adaptation. Previously, she has been working on Evaluation at IIED. She has a PhD in Natural Resources and Conservation.

For the Initiative for Climate Action Transparency (ICAT), she has developed a guide and tools that support developing countries in improving transparency on their climate finance needs and existing flows. He participates in international climate negotiations and furthers the field of climate action through various publications. His technical backround is in Business Economics and Applied Statistics.

#### MATEJ GASPERIC GREENHOUSE GAS MANAGEMENT INSTITUTE (GHGMI)



Matej is the Mitigation Program Director at GHGMI. In his role, he leads strategic planning and program management efforts and technical support aimed at reducing greenhouse gas emissions and provides technical support the Caribbean Cooperative Measurement, Reporting and Verification Hub (MRV Hub). Prior to joining GHGMI, Matej was head of department and advisor to the Government of the Republic of Slovenia and an independent consultant. Among others, he was responsible for the establishment of a national MRV system for greenhouse gases/air pollutants and the preparation and implementation of emission trading in Slovenia and revision of the carbon taxation scheme. As UNFCCC reviewer for greenhouse gas inventories of Annex I countries and lead reviewer for national communications and biennial update reports, Matej is actively involved in the annual UNFCCC inventory review process. His technical background is in mechanical engineering with a focus on energy and processes.

#### JIGME UNFCCC SECRETARIAT



Jigme leads a professional team in the UNFCCC secretariat that supports Parties to the UNFCCC to prepare, submit and implement their nationally appropriate mitigation actions, Nationally Determined Contributions, and long-term low GHG emissions development strategies, and that provides technical assistance on the existing MRV arrangements. He also leads the support to the intergovernmental negotiations on issues relating to provision of financial and technical support to developing country Parties for MRV, and development of modalities, procedures and guidelines for the transparency framework under the Paris Agreement. Prior to joining the secretariat, Jigme was working for the Royal Government of Bhutan as a technical focal point for climate change and air quality. By profession, he is a meteorologist.

#### LORENZ MOOSMANN ÖKO-INSITUT E.V.



Lorenz is an expert for greenhouse gas inventories and projections. He has participated in the UNFCCC negotiations in the area of transparency since 2017. Lorenz is working as a senior researcher at Öko-Institut since 2018. He is an environmental scientist by training.

Vlad is the manager of information hub, data and tools in the Transparency Division of the UNFCCC secretariat. His technical training is in environmental economics and management.

Cristina Urrutia has been at Öko-Institut since 2019. Before that she worked for the Ministry of Environment of Peru and for the Ministry of Environment - of Germany, actively participating in the UNFCCC process until 2018. She is a biologist by training.

Joana is a climate change expert with a strong background in international affairs, gender equality and citizen's engagement. Joana was Portugal's Head of Delegation to the UNFCCC and the Paris Agreement for several years. Master of Air pollution management, Julien Vincent joined Citepa in 2002 after working in an analytical chemistry laboratory at CSULA, California (1999/2000). Due to the study of activities related to solvent emissions, non-road mobile machinery (NRMM) emissions and the costs of abatement techniques, Julien Vincent became Deputy Inventory Manager in 2008 and then, head of the team in charge of energy balance, the manufacturing industry and the realization of carbon footprint (Bilan Carbone®), at the beginning of 2009. 
